
MSCI EMU High Dividend Yield Low Carbon SRI Screened Select Index (EUR)

The Index is designed to represent the performance of a strategy that seeks systematic integration of environmental, social and governance (ESG) norms and maximizes its exposure to the Dividend Yield factor while limiting the Tracking Error relative to the MSCI EMU Index.


