# MSCI EMU Select ESG Rating and Trend Leaders Index (EUR)

The MSCI EMU Select ESG Rating and Trend Leaders Index is based on the parent index, MSCI EMU Index which covers large and midcap stocks across 10 developed markets (DM) countries\* in the EMU. The index is designed to represent the performance of companies that have a robust ESG profile as well as a positive trend in improving that profile. The Index aims to target sector weights that reflect the relative sector weights of the underlying index to limit the systematic risk introduced by the ESG selection process. Overall the Index targets coverage of 50% of the underlying MSCI EMU Index.




