The MSCI EMU ex Financials Index captures large and mid cap representation across the 10 Developed Markets (DM) countries in the European Economic and Monetary Union (EMU)*. With 171 constituents, the index covers approximately 85% of the free float-adjusted market capitalization of the EMU. The Index excludes securities that are classified in the Financials sector as per the Global Industry Classification Standard (GICS®).

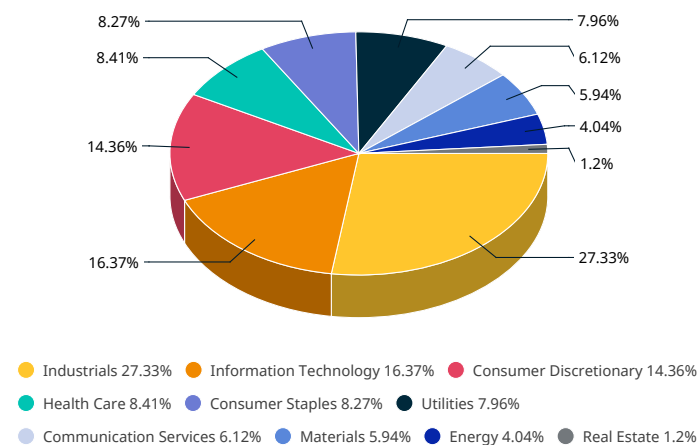

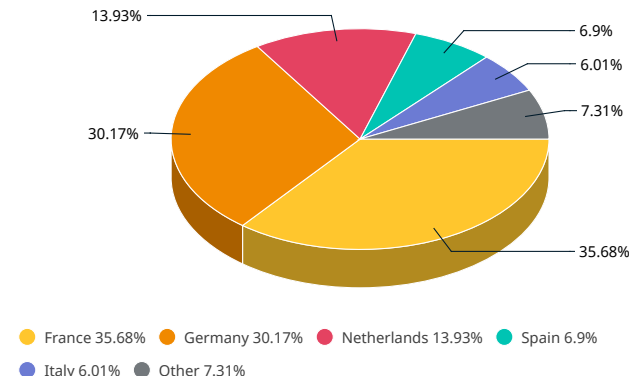
