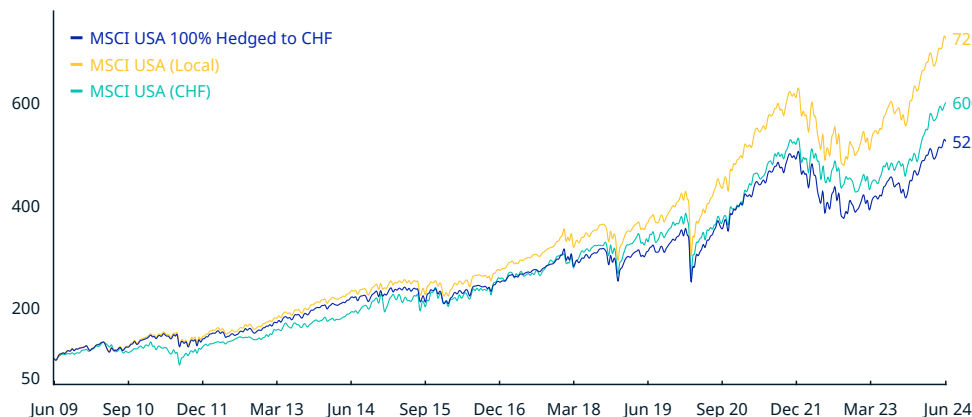


MSCI USA 100% Hedged to CHF Index (CHF)

The **MSCI USA 100% Hedged to CHF Index** represents a close estimation of the performance that can be achieved by hedging the currency exposure of its parent index, the MSCI USA Index, to the CHF, the "home" currency for the hedged index. The index is 100% hedged to the CHF by selling the USD forward at the one-month Forward rate. The parent index is composed of large and mid cap stocks.
