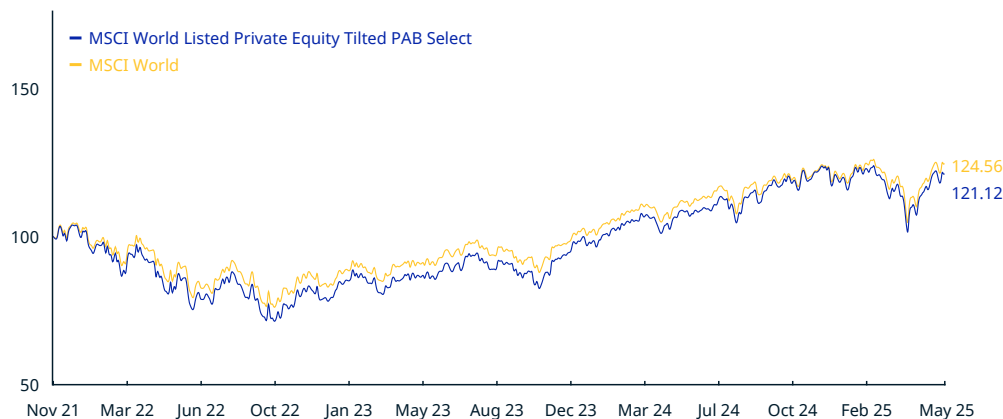


MSCI World Listed Private Equity Tilted PAB Select Index (USD)

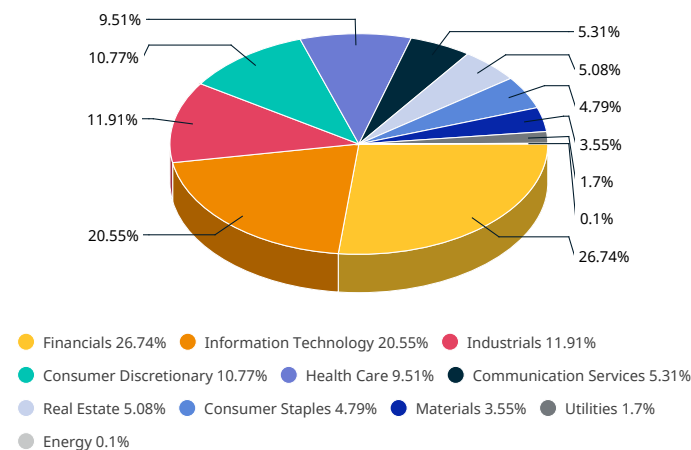

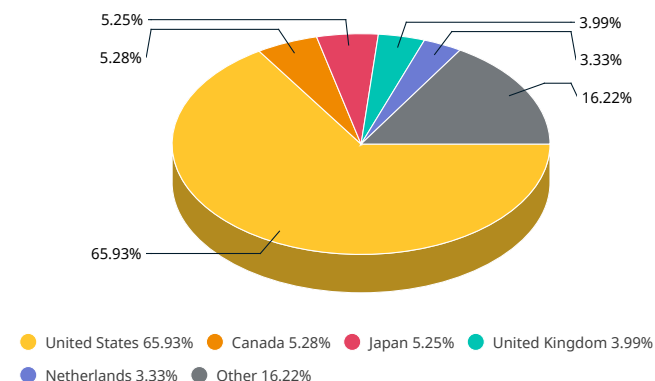
