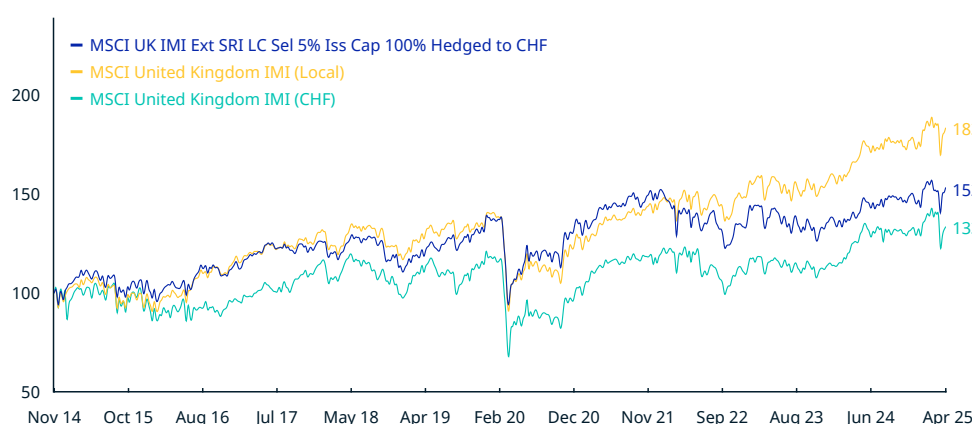


MSCI UK IMI Extended SRI Low Carbon Select 5% Issuer Capped 100% Hedged to CHF Index (CHF)

The MSCI United Kingdom IMI Extended SRI Low Carbon Select 5% Issuer Capped 100% Hedged to CHF Index represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI United Kingdom Index, to the CHF the "home" currency for the hedged index. The index's exposure to developed market country constituents is 100% hedged to the CHF by selling each foreign currency forward at the one-month Forward rate. The parent index is composed of large, mid and small-cap stocks of the U.K markets. The index is designed to represent the performance of companies that have lower carbon exposure than that of the broad market and have high Environmental, Social and Governance (ESG) performance. Further, the Index also aims to avoid concentration by capping issuers within the Index to a maximum weight of 5% in accordance with the MSCI Capped Indexes methodology.
