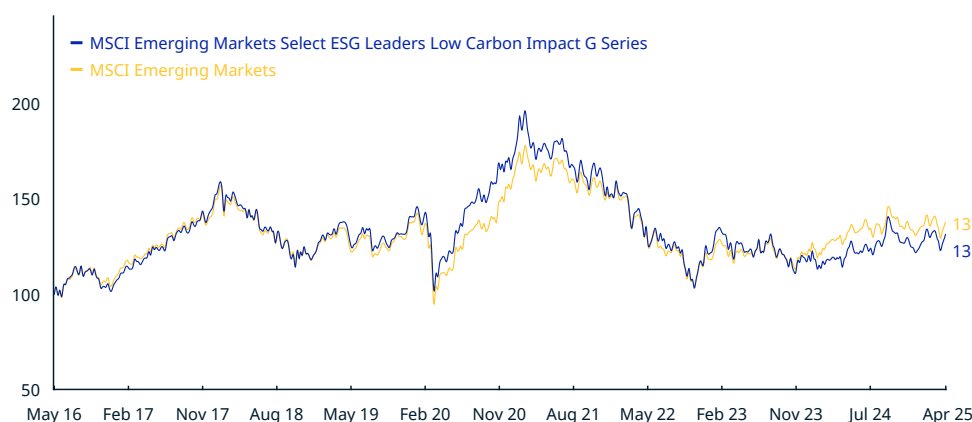


# MSCI Emerging Markets Select ESG Leaders Low Carbon Impact G Series Index (USD)

The MSCI Emerging Markets Select ESG Leaders Low Carbon Impact G Series Index is based on the MSCI Emerging Markets Index, its parent index, and includes large and mid-cap securities across 24 Emerging Markets (EM) countries\*. The Index aims to reflect a lower carbon exposure than that of the broad market by selecting companies with low carbon emissions relative to sales and those with low potential carbon emissions per dollar of market capitalization. Additionally, the Index applies certain values-based exclusion criteria. Finally, the weights of securities are tilted in proportion of the aggregated Sustainable Impact Revenue contribution from the following components: Alternative Energy, Energy Efficiency, Green Building, Pollution Prevention, Major Disease Treatment, Nutrition.

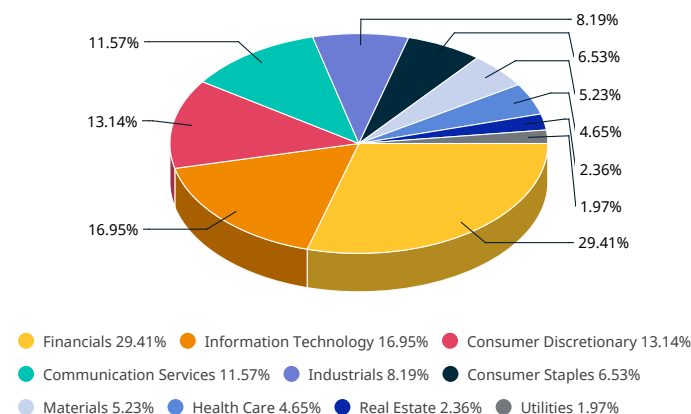

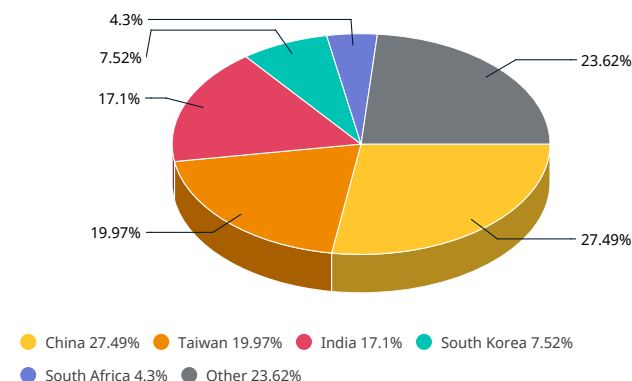
