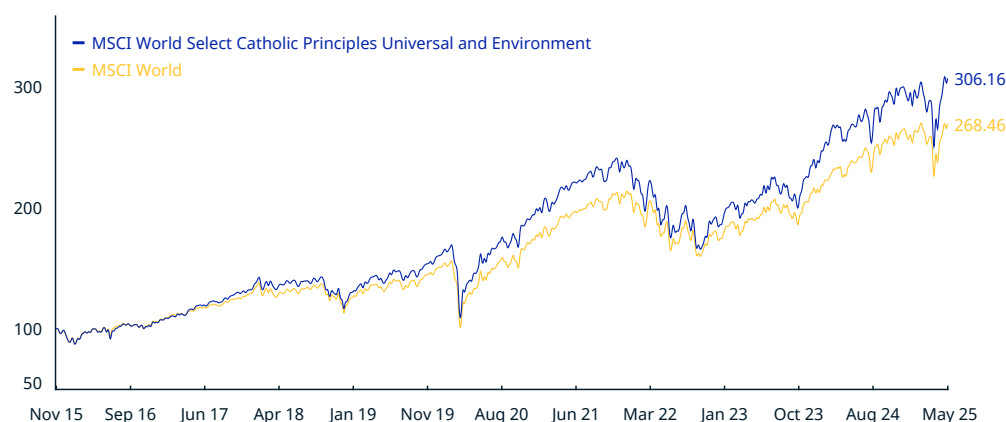


MSCI World Select Catholic Principles Universal Index (USD)

The MSCI World Select Catholic Principles Universal and Environment Index is based on the MSCI World Index, its parent index, and includes large and mid-cap stocks across 23 Developed Markets countries*. The Index is designed to represent the performance of a strategy that aims to select companies having lower carbon exposure and higher Environmental, Social and Governance (ESG) performance than that of the broad market, while excluding companies that are involved in controversial businesses like weapons, gambling, adult entertainment, etc. The Index also excludes companies that are involved in abortion and contraceptives, stem cell research, and animal testing.

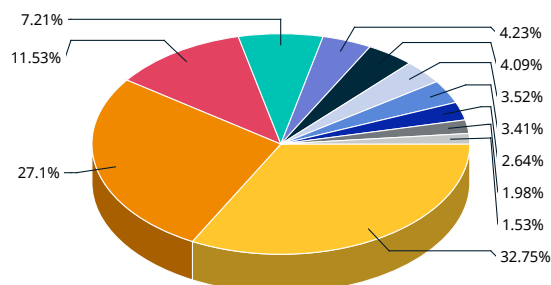

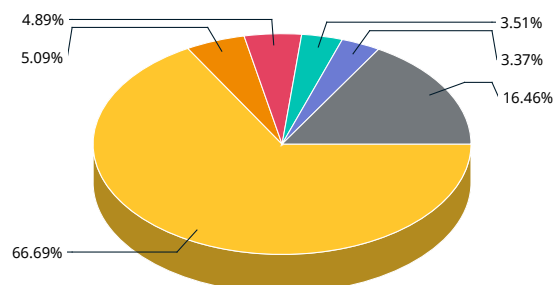
