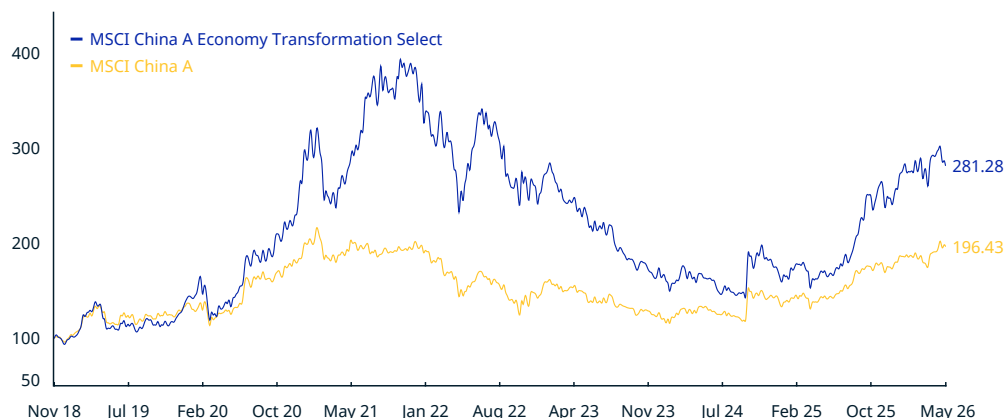


# MSCI China A Economy Transformation Select Index (USD)

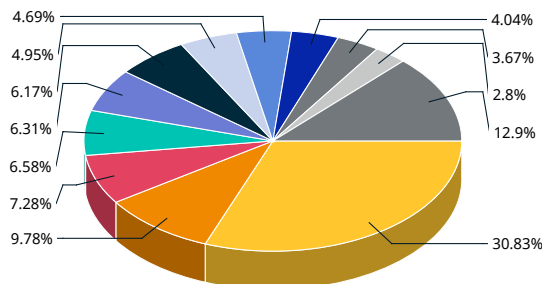
