MSCI South India High Quality 25 only Includes top 25 companies whose headquarters are in select 5 Indian states (Karnataka, Kerala, Andhra Pradesh, Telangana, and Tamil Nadu) ranked by Sector Relative Quality score.

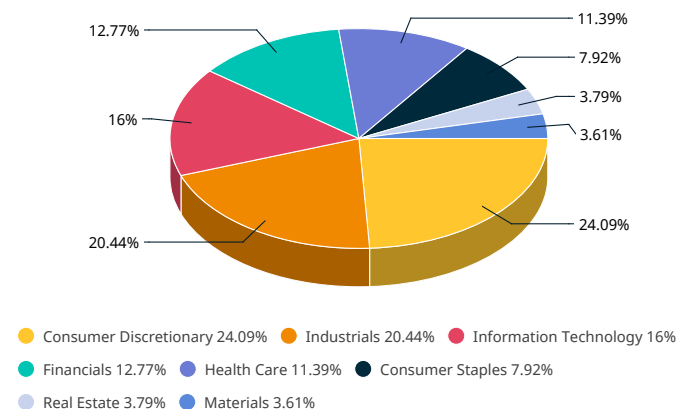
