# **MSCI Emerging Markets Low Carbon Leaders Index** (USD)

The MSCI Emerging Markets Low Carbon Leaders Index is based on the MSCI Emerging Markets Index, its parent index, and includes large and mid-cap stocks across 24 Emerging Markets (EM) countries\*. The index addresses two dimensions of carbon exposure carbon emissions and fossil fuel reserves - providing clients with an effective tool for limiting the exposure of their portfolios to carbon risk. By excluding companies with the highest carbon emissions intensity and the largest owners of carbon reserves per dollar of market capitalization, the index aims to achieve at least 50% reduction in its carbon footprint. The index also aims to maintain wide and consistent market exposure by minimizing the tracking error relative to the MSCI Emerging Markets Index. The MSCI Global Low Carbon Leaders Indexes use MSCI ESG Carbon Metrics data from MSCI ESG Research Inc.






# FACTORS - KEY EXPOSURES THAT DRIVE RISK AND RETURN **MSCI FACTOR BOX**



## SECTOR WEIGHTS



The MSCI Factor Box, which is powered by MSCI FaCS, provides a visualization designed to easily compare absolute exposures of funds/indexes and their benchmarks along 6 Factor Groups that have historically demonstrated excess market returns over the long run.
