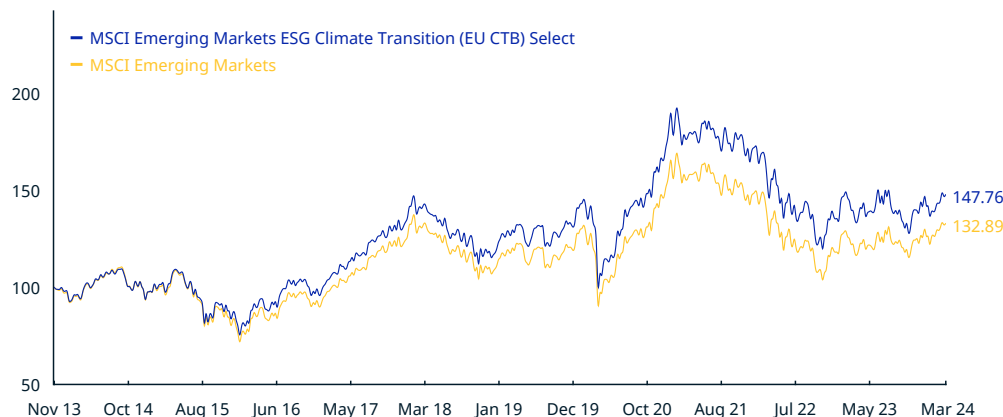


MSCI Emerging Markets ESG Climate Transition (EU CTB) Select Index (USD)

The MSCI Emerging Markets ESG Climate Transition (EU CTB) Select Index is based on the MSCI Emerging Markets Index, its parent index, and includes large and mid-cap securities across 24 Emerging Markets (EM) countries*. The index is designed to exceed the minimum standards of the EU Climate Transition Benchmark (CTB) under the EU Benchmark Regulation (EU delegated acts).

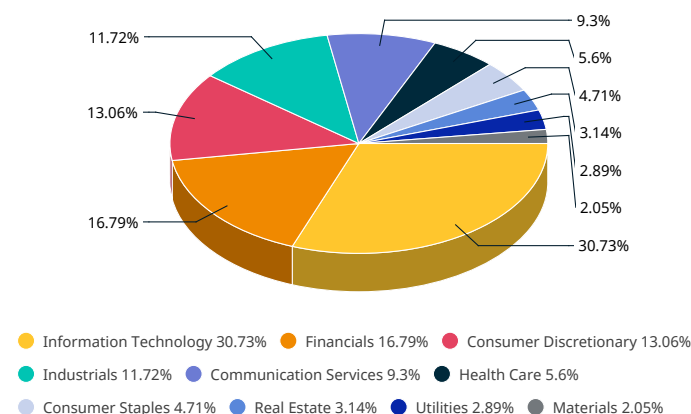

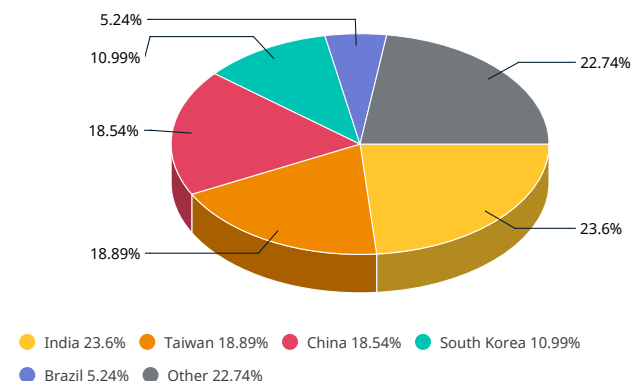
