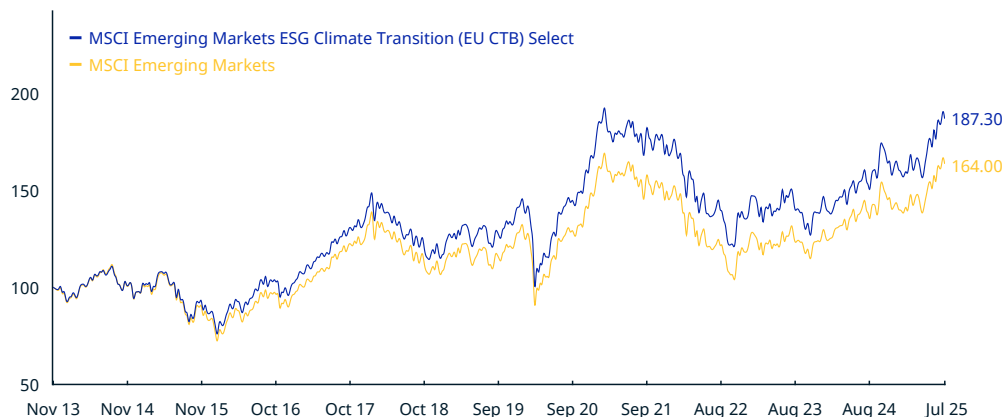


MSCI Emerging Markets ESG Climate Transition (EU CTB) Select Index (USD)

The index is designed to exceed the minimum standards of the EU Climate Transition Benchmark (CTB) under the EU Benchmark Regulation (EU delegated acts).

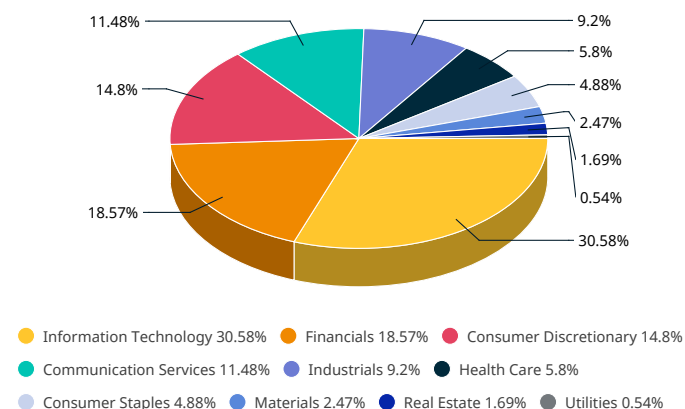

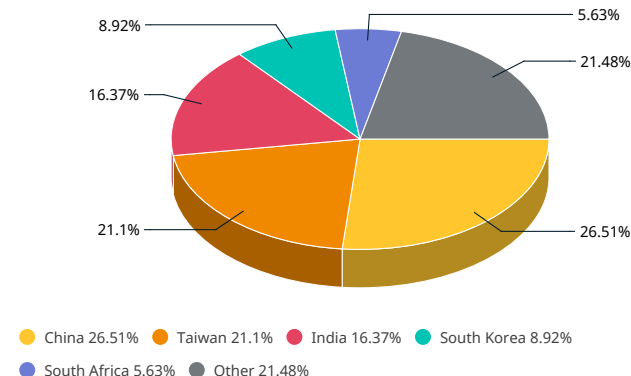
