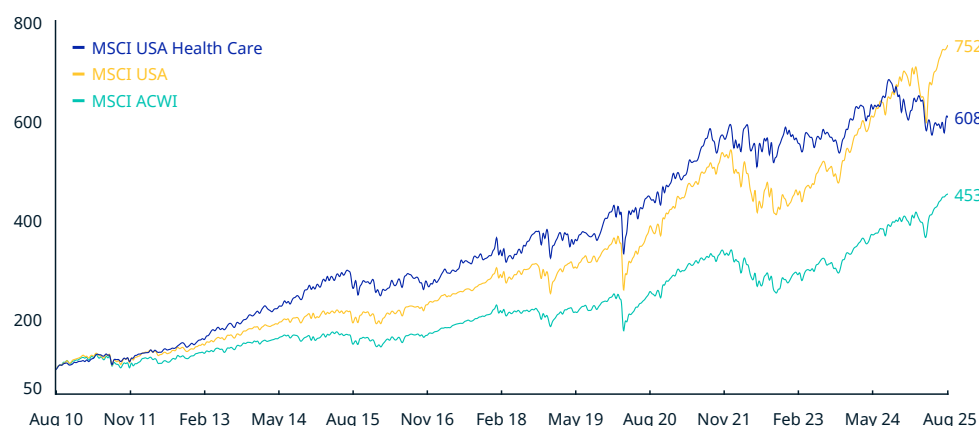


MSCI USA Health Care Index (USD)

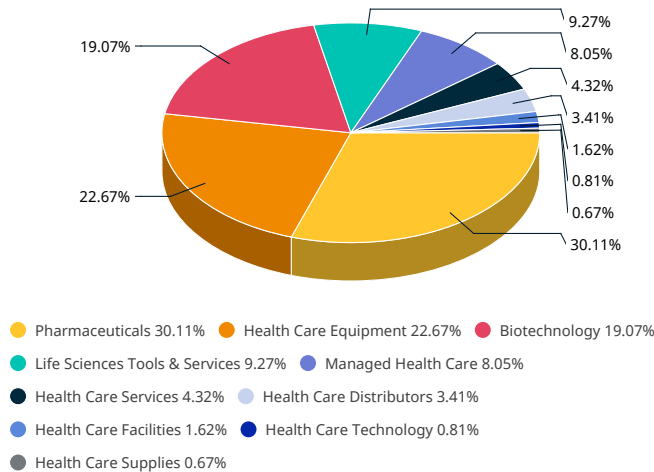
