

MSCI November Semi-Annual Index Review Announcement Scheduled for November 12, 2015

New York – November 5, 2015 – MSCI Inc. (NYSE: MSCI), a leading provider of research-based indexes and analytics, will announce the results of the November 2015 Semi-Annual Index Review for the MSCI Equity Indexes – including the MSCI Global Standard, MSCI Global Small Cap and MSCI Micro Cap Indexes, the MSCI Global Value and Growth Indexes, the MSCI Frontier Markets and MSCI Frontier Markets Small Cap Indexes, the MSCI Global Islamic and MSCI Global Islamic Small Cap Indexes, the MSCI Pan-Euro and MSCI Euro Indexes, the MSCI US Equity Indexes, the MSCI US REIT Index, and the MSCI China A Indexes. All changes will be made as of the close of November 30, 2015.
