


MSCI EMU SRI Low Carbon Select 5% Issuer Capped 100% Hedged to CHF Index (CHF)

The MSCI EMU SRI Low Carbon Select 5% Issuer Capped 100% Hedged to CHF Index represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI EMU Index, to the CHF the "home" currency for the hedged index. The index's exposure to developed market country constituents is 100% hedged to the CHF by selling each foreign currency forward at the one-month Forward rate. The parent index is composed of large and mid-cap stocks across 10 Developed Markets (DM) countries* in the EMU. The index is designed to represent the performance of companies that have lower carbon exposure than that of the broad market and have high Environmental, Social and Governance (ESG) performance. Further, the Index also aims to avoid concentration by capping issuers within the Index to a maximum weight of 5% in accordance with the MSCI Capped Indexes methodology.


