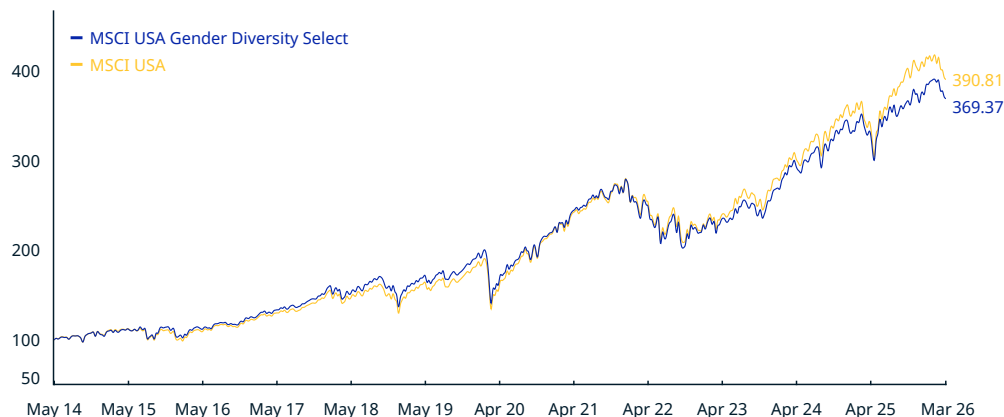


MSCI USA Gender Diversity Select Index (USD)

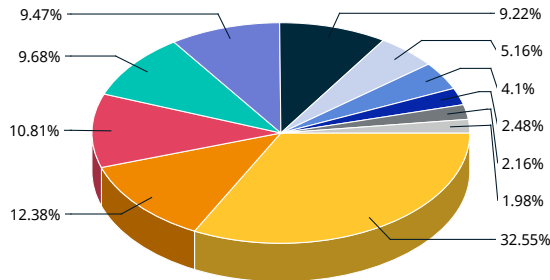
