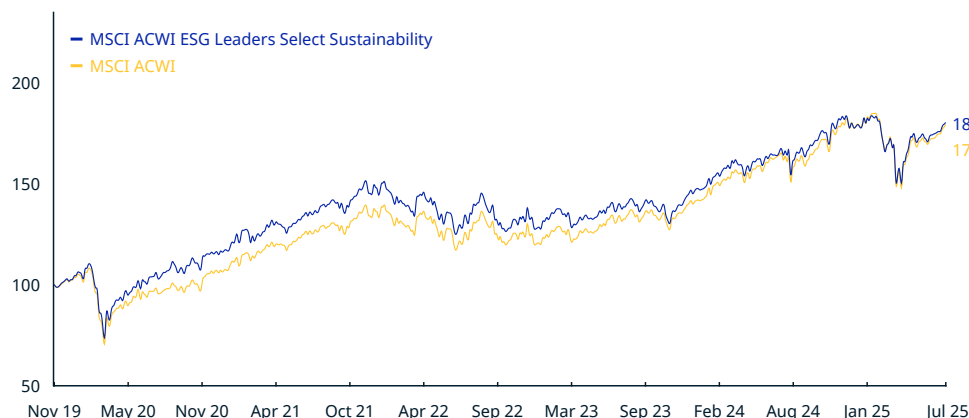


# MSCI ACWI ESG Leaders Select Sustainability Index (EUR)

The MSCI ACWI ESG Leaders Select Sustainability Index\* is based on the MSCI ACWI Index, its parent index, and includes large and mid-cap securities across 23 Developed Markets (DM) and 24 Emerging Markets (EM) countries\*\*. The index aims to represent the performance of an investment strategy that selects securities of companies that have high Environmental, Social and Governance (ESG) ratings relative to their sector peers and reweights the constituents to meet additional climate requirements imposed.

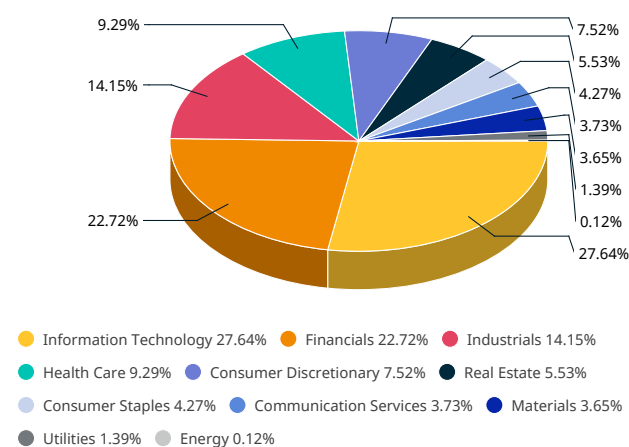

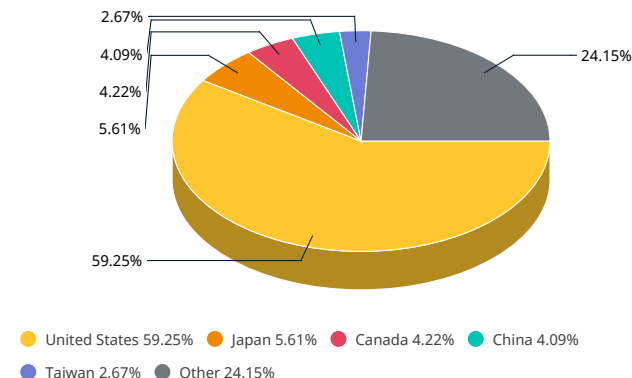
