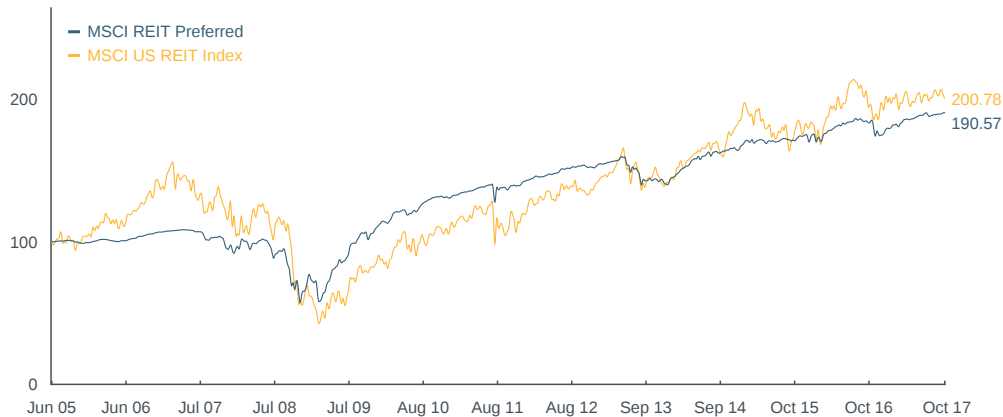


MSCI REIT PREFERRED INDEX (USD)

The MSCI REIT Preferred Index [Methodology](#) contains the guidelines MSCI uses to construct and maintain the MSCI REIT Preferred Index. Non-convertible perpetual preferred securities with fixed dividends or indexed yields, issued by US Equity and US Hybrid REITs, that trade on the NYSE, AMEX, or NASDAQ are eligible for inclusion in the index. To ensure the appropriate reflection of the eligible preferred US REIT universe, the MSCI REIT Preferred Index is fully reviewed on a quarterly basis, at the end of March, June, September and December.
