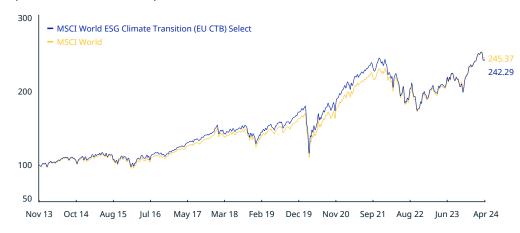
MSCI World ESG Climate Transition (EU CTB) Select Index (USD)

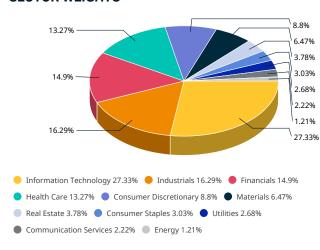

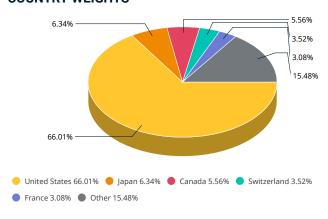
