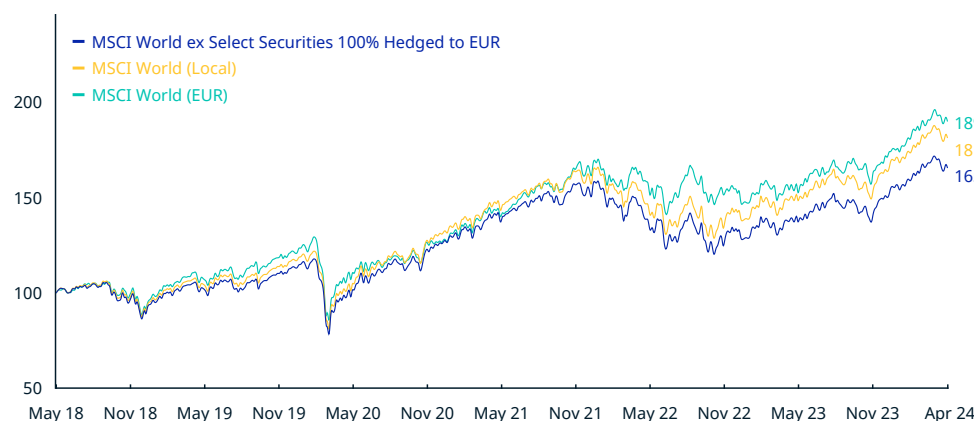


# MSCI World ex Select Securities 100% Hedged to EUR Index (EUR)

The MSCI World ex Select Securities 100% Hedged to EUR Index represents a close estimation of the performance that can be achieved by hedging the currency exposures of its parent index, the MSCI World ex Select Securities Index, to the EUR, the "home" currency for the hedged index. The index is 100% hedged to the EUR by selling each foreign currency forward at the one-month Forward weight. The parent index is composed of large and mid cap stocks across 23 Developed Markets (DM) countries\* after excluding a set of securities\*\* from the MSCI World.

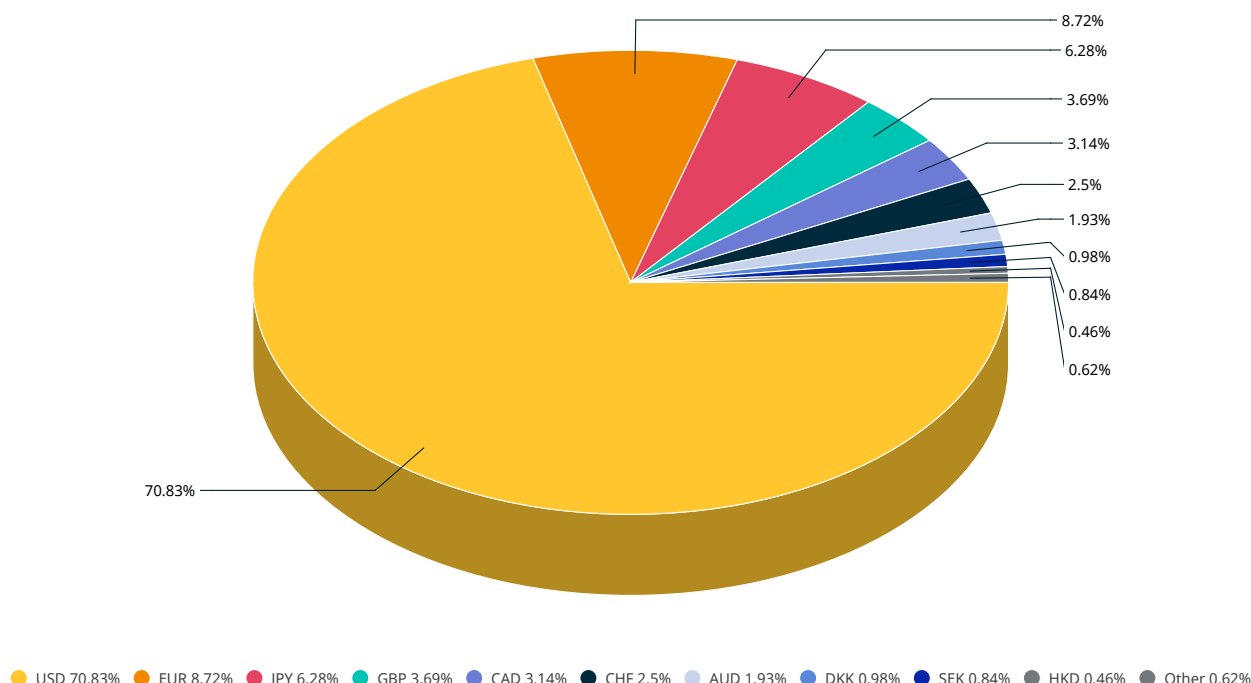
