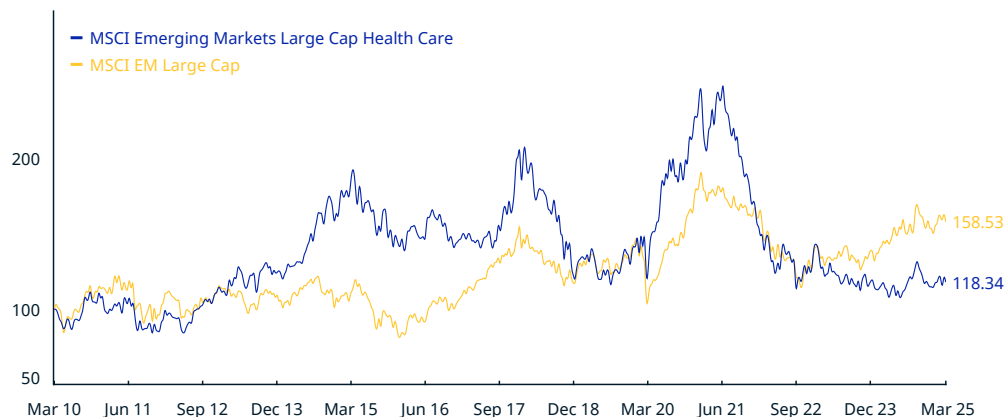


# MSCI Emerging Markets Large Cap Health Care Index (USD)

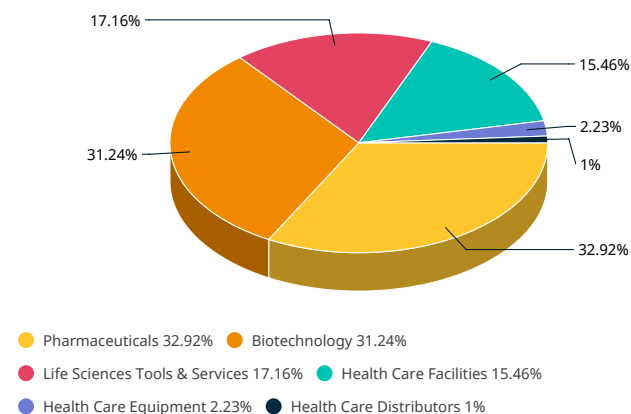

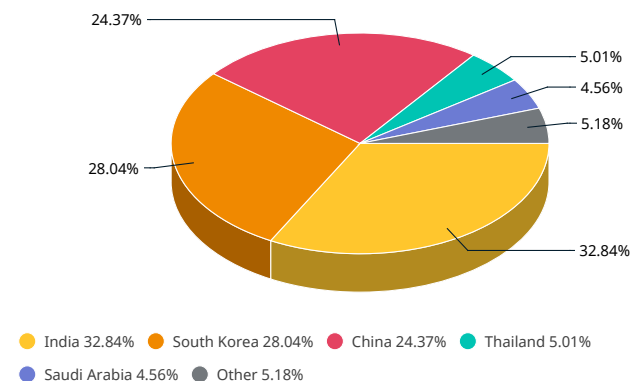
