


MSCI World Selection 5% Decrement Index (EUR)

The MSCI World Selection 5% Decrement Index is based on MSCI World Selection Index, its parent index and provides exposure to companies with high Environmental, Social and Governance (ESG) performance relative to their sector peers. The MSCI World Selection Index consists of large and mid-cap companies in 23 developed markets countries*. The Index is designed for investors seeking a broad, diversified sustainability benchmark with relatively low tracking error to the underlying equity market. The parent index is a member of the MSCI Selection Index series. Constituent selection is based on data from MSCI ESG Research. The index applies a constant markdown ('synthetic dividend') of 5% on an annual basis, expressed as a percentage of performance.




