The index is weighted in accordance with the MSCI Capped Indexes methodology, such that the largest group entity within each Index is capped at 35% while all other group entities are capped at 20%, with a buffer of 10% applied on these limits at each index rebalancing.





In addition to the above, companies that fail to comply with the United Nations Global Compact Principles are also excluded from the MSCI ESG Screened Indexes. Further, the companies are required to have an MSCI ESG Rating of 'B' or above to be eligible for inclusion in the MSCI World Sector ESG Screened 20-35 Select Indexes. The index is weighted in accordance with the MSCI Capped Indexes methodology, such that the largest group entity within each Index is capped at 35% while all other group entities are capped at 20%, with a buffer of 10% applied on these limits at each index rebalancing. The index is reviewed in February, May, August and November, coinciding with the quarterly and semiannually index reviews of MSCI Global Investable Market Indexes. The MSCI World Sector ESG Screened 20-35 Select Indexes are also reviewed monthly on an "as needed" basis. This means that an MSCI World Sector ESG Screened 20-35 Select Indexes are rebalanced at the end of every month on which the 35% and 20% constraints (without the buffer) are breached.
