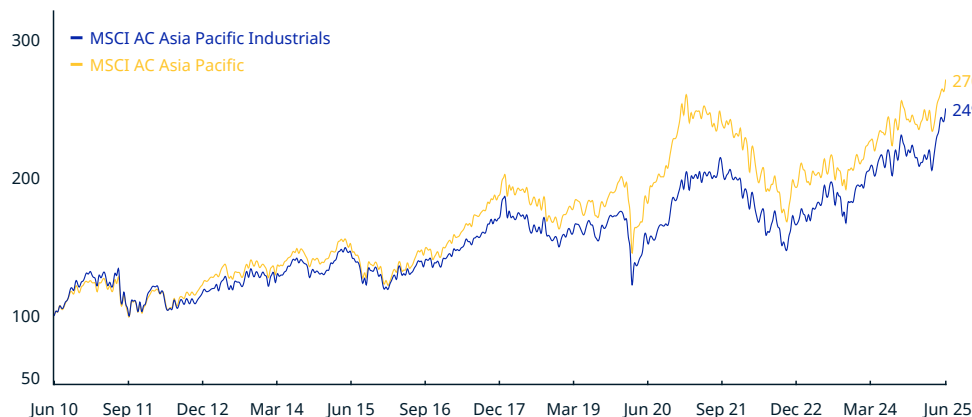


MSCI AC Asia Pacific Industrials Index (USD)

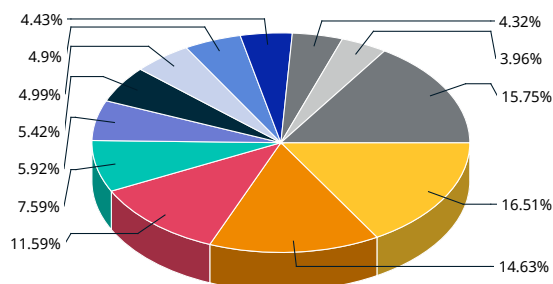

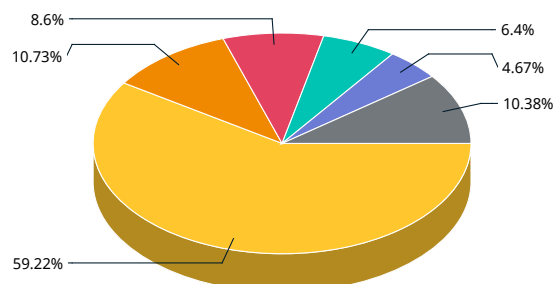
