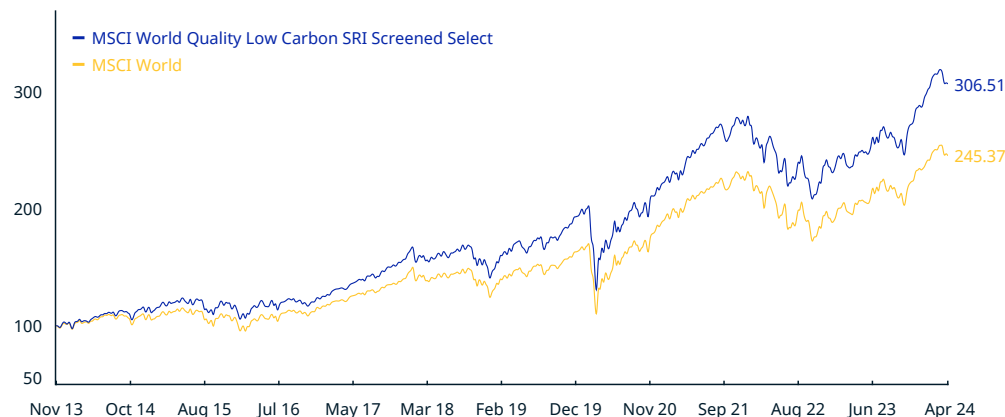


MSCI World Quality Low Carbon SRI Screened Select Index (USD)

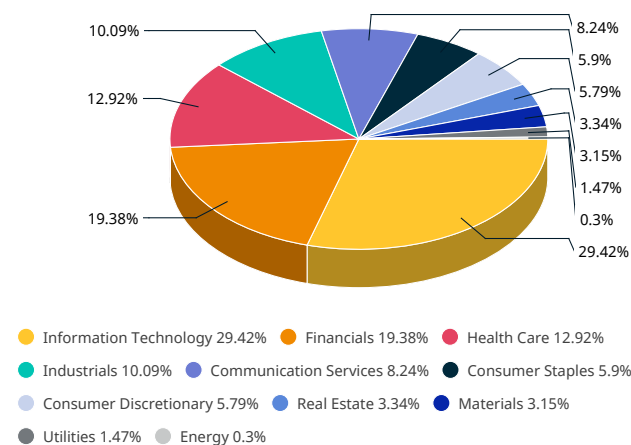

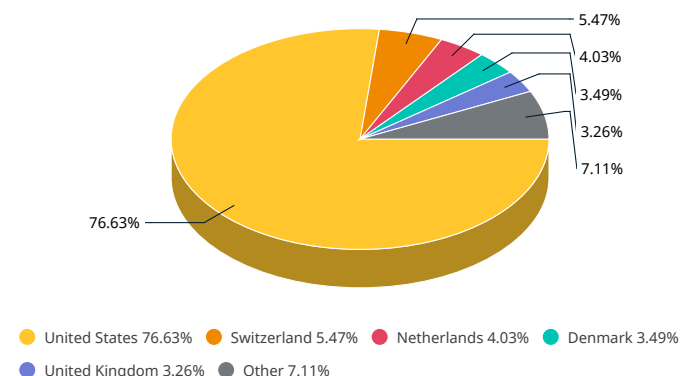
