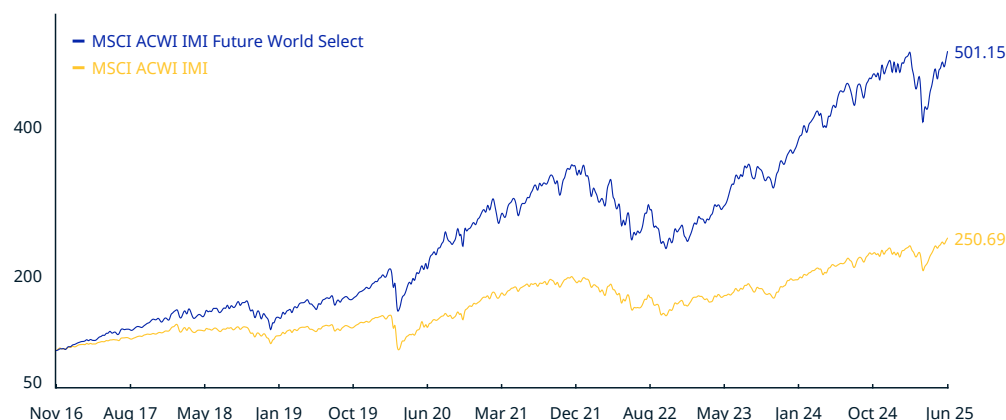


MSCI ACWI IMI Future World Select Index (USD)

The MSCI ACWI IMI Future World Select Index is based on the MSCI ACWI IMI Index, its parent index, and includes large, mid and small-cap securities across 23 Developed Markets (DM) and 24 Emerging Markets (EM) countries*. The index is constructed by combining selected uncapped MSCI Global Select Top 30 Thematic Indexes in a pre-determined weight proportion. The issuers in the index are capped to a maximum weight of 8%.

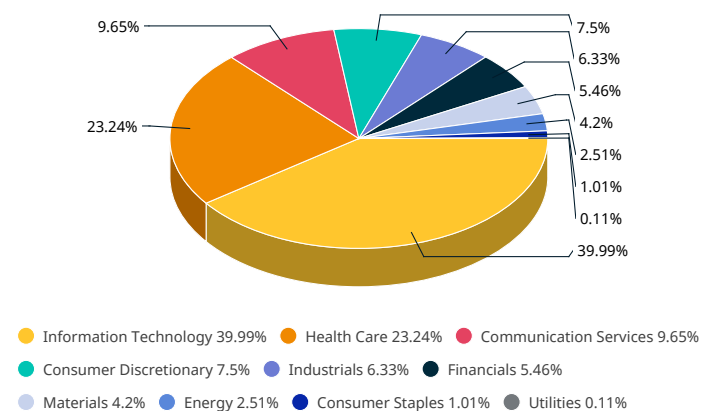

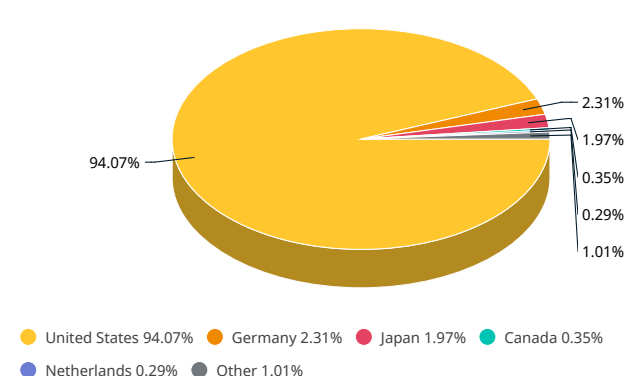
