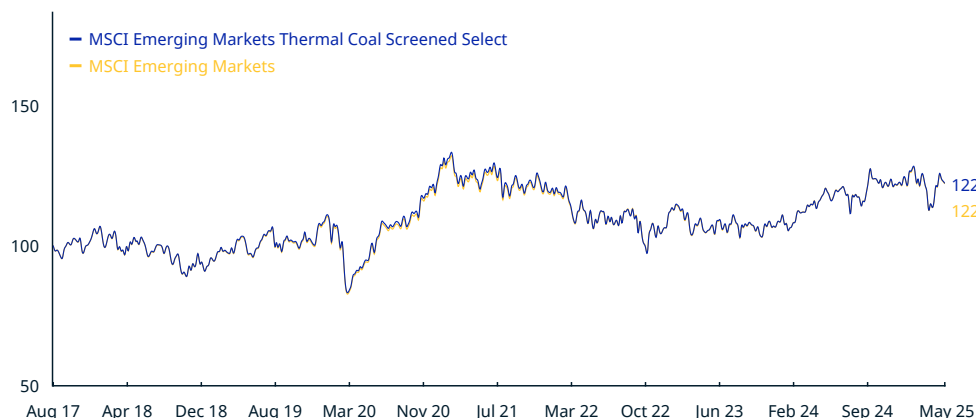


MSCI Emerging Markets Thermal Coal Screened Select Index (GBP)

MSCI Emerging Markets Thermal Coal Screened Select Index is based on MSCI Emerging Markets Index which captures large and mid cap representation across 24 Emerging Markets (EM) countries*. The Index constituents are weighted according to their free float adjusted market capitalizations applicable to foreign investors. A selection of securities using pre-defined Business Involvement screens (BISR) will be excluded from the constituent list of the Parent Index.

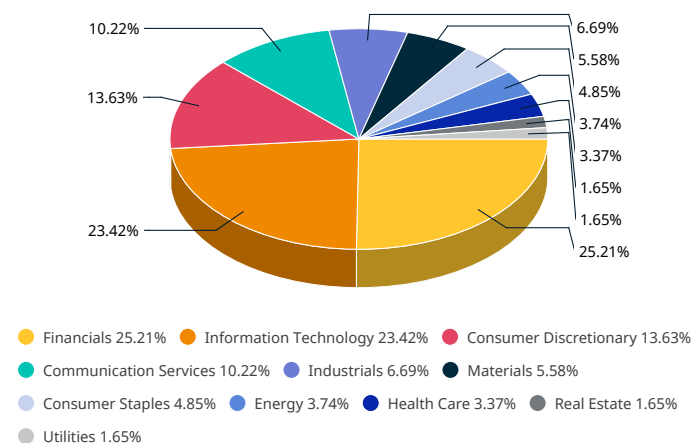

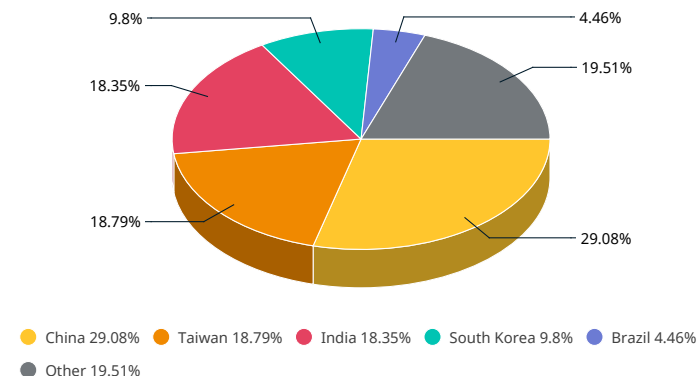
