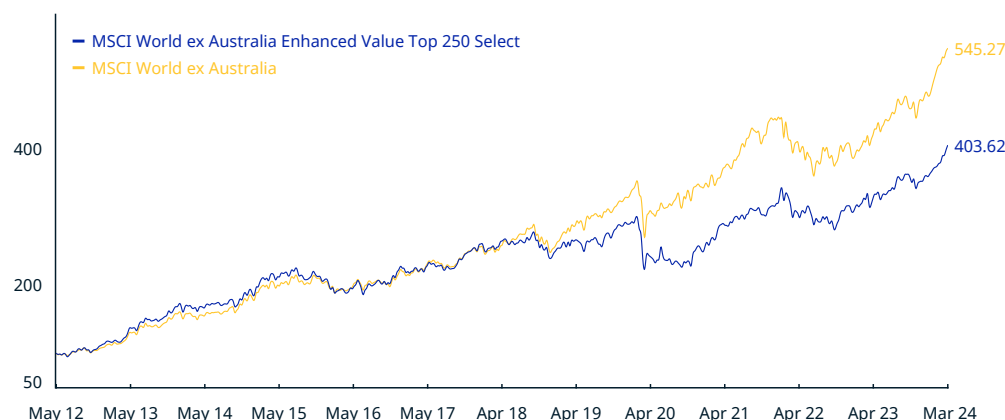


MSCI World ex Australia Enhanced Value Top 250 Select Index (AUD)

The MSCI World ex Australia Enhanced Value Top 250 Select Index is based on the MSCI World ex Australia Index, its parent index which captures large and mid cap companies in 22 Developed Markets (DM) Countries*. The MSCI World ex Australia Enhanced Value Top 250 Select Index aims to represent the performance of a set of 250 securities that exhibit relatively higher value characteristics compared to the parent index while excluding companies involved in controversial, nuclear and conventional weapons, and tobacco.

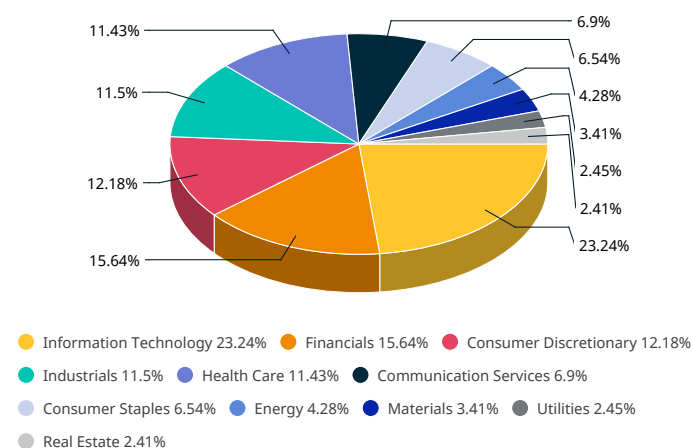

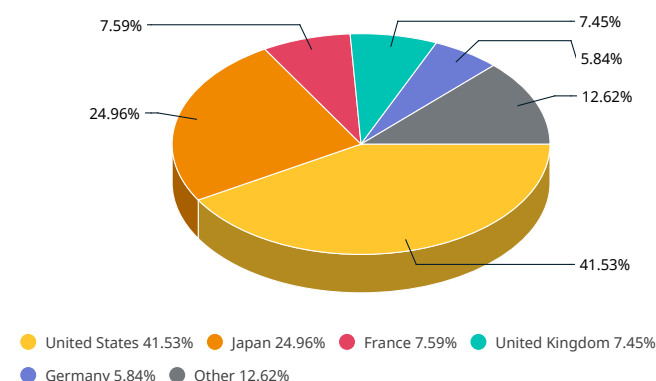
