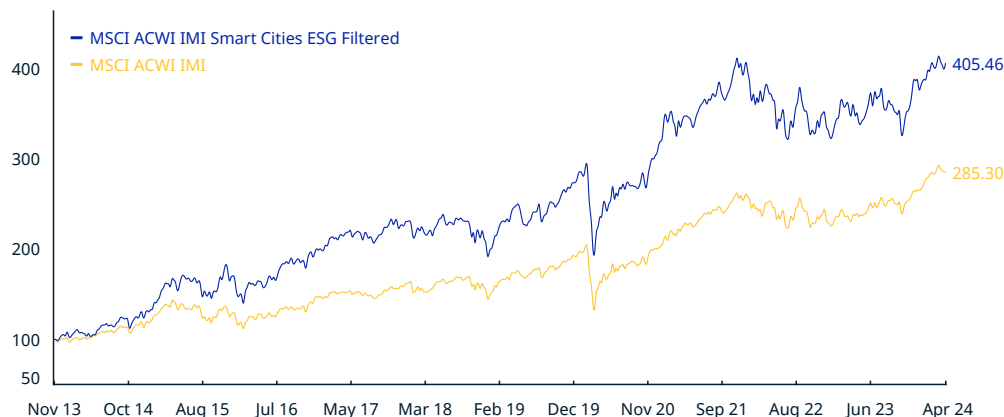


MSCI ACWI IMI Smart Cities ESG Filtered Index (EUR)

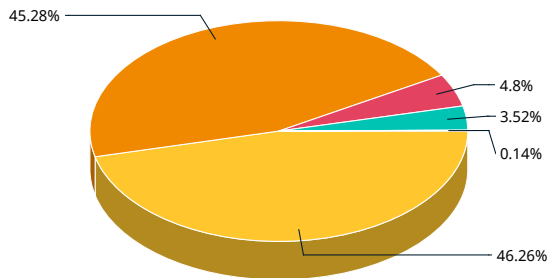

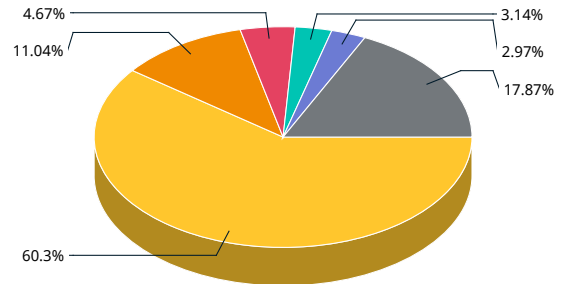
