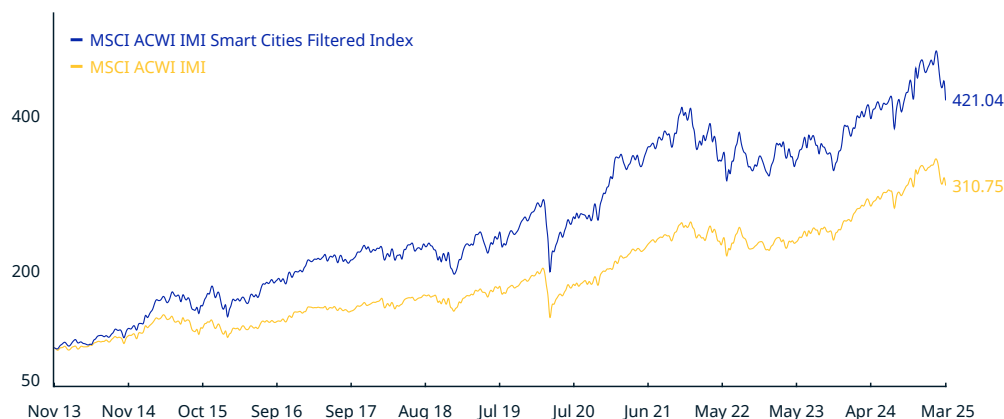


MSCI ACWI IMI Smart Cities Filtered Index (EUR)

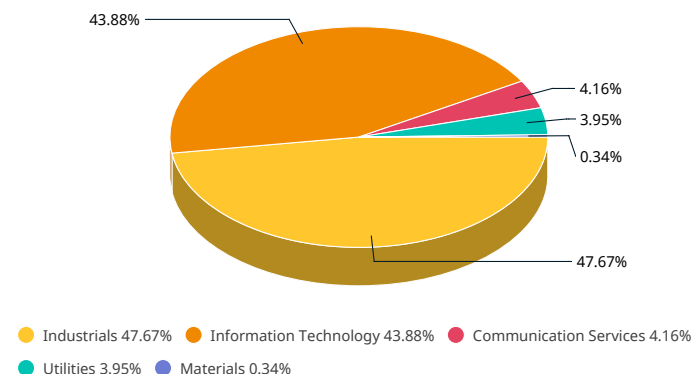

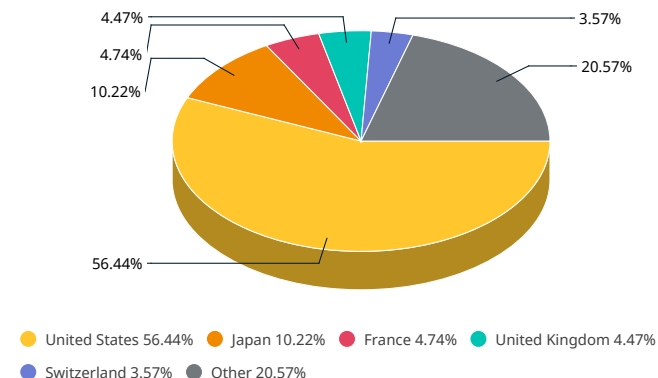
