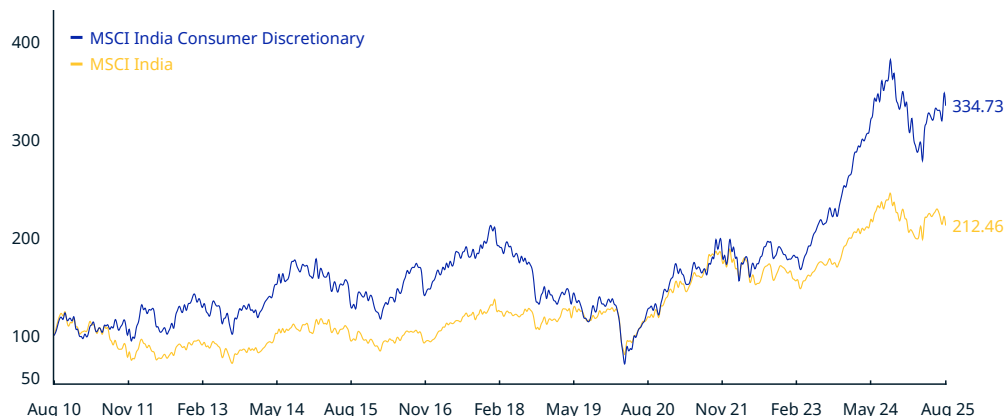


MSCI India Consumer Discretionary Index (USD)

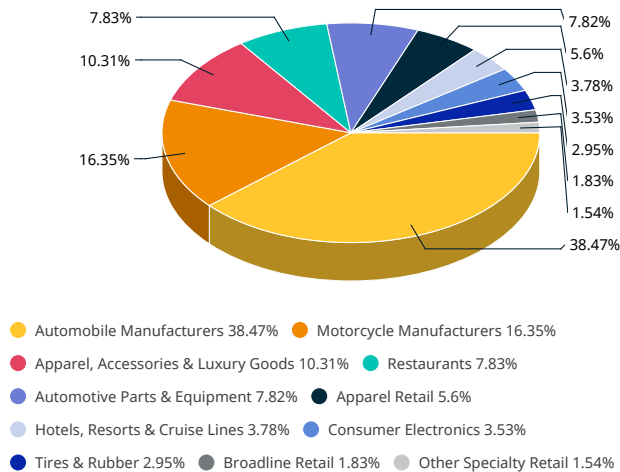
