
MSCI France Select ESG 30 4% Decrement Gross Index (EUR)

The MSCI France Select ESG 30 4% Decrement Index (Gross) is based on the MSCI France IMI Index, its parent index, and includes large and mid and small cap segments of the French Market. The Index aims to represent the gross performance of a set of 30 stocks from the parent index that have high Environmental, Social and Governance (ESG) scores, which are then picked in descending order of their free float-adjusted market capitalization. The Index aims to avoid concentration by capping the weight of securities within the index to a maximum of 5%, while applying a constant markdown ('synthetic dividend') of 4% on an annual basis, expressed as a percentage of performance.



Index methodology

The MSCI France Select ESG 30 4% Decrement Index (Gross) is constructed from MSCI France IMI Index, its parent index. The Index aims to represent the gross performance of a set of 30 stocks from the parent index that have high Environmental, Social and Governance (ESG) scores. The Index aims to avoid concentration by capping the weight of securities within the index to a maximum of 5%, while applying a constant markdown ('synthetic dividend') of 4% on the gross total return variant on an annual basis, expressed as a percentage of performance.

The index is reviewed on a quarterly basis coinciding with the May and November Semi-Annual Index Reviews and the February and August Quarterly Index Reviews of the Parent Index.
