
# MSCI EM IMI Custom Low Carbon Target Special Tax Rates Index (USD)

The MSCI EM IMI Custom Low Carbon Target Special Tax Rates Index includes large, mid and small cap representation across 24 Emerging Markets (EM) countries\*. The Index is weighted and rebalanced according to the MSCI Global Low Carbon Target Indexes Methodology with certain exceptions for defining the Optimization Parameters and applies changeable tax rates. The MSCI Global Low Carbon Target Indexes are benchmarks for investors who wish to manage potential risks associated with the transition to a low carbon economy. By over weighting companies with low carbon emissions (relative to sales) and those with low potential carbon emissions (per dollar of market capitalization), the index reflects a lower carbon exposure than that of the broad market. It uses MSCI ESG Carbon Metrics data from MSCI ESG Research Inc.




