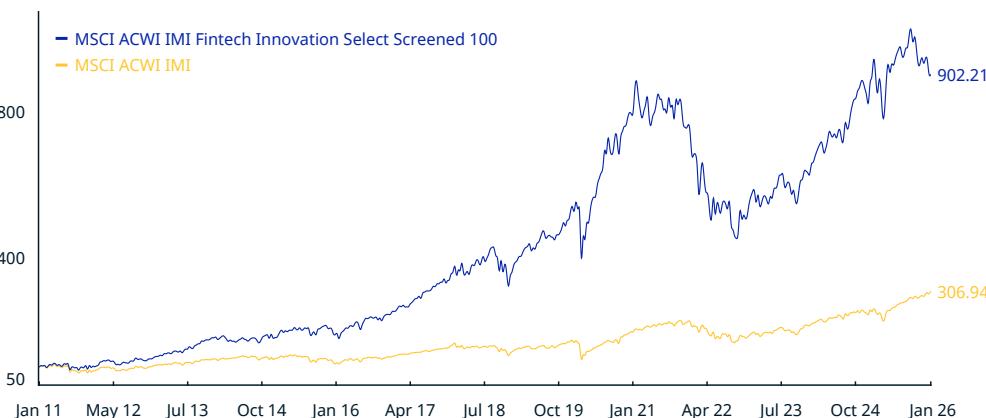


# MSCI ACWI IMI Fintech Innovation Select Screened 100 Index (USD)

The MSCI ACWI IMI Fintech Innovation Select Screened 100 Index is based on the MSCI ACWI IMI Index, its parent index, and includes large, mid and small-cap securities across 23 Developed Markets (DM) and 20 Emerging Markets (EM) countries\*. The Index aims to represent the performance of a set of companies that are expected to derive significant revenues, based on the underlying index methodology criteria, from the development of new products and services as a result of technological innovation in the financial sector while excluding those involved in certain controversial businesses or with relatively low ESG Ratings.

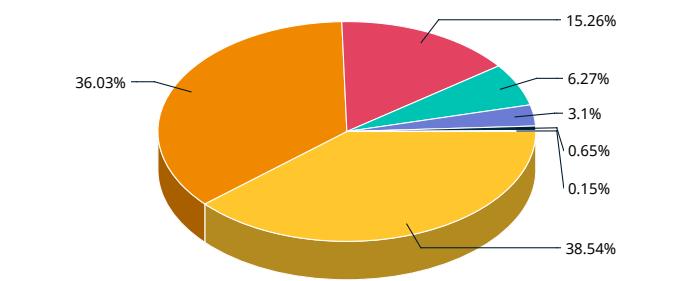

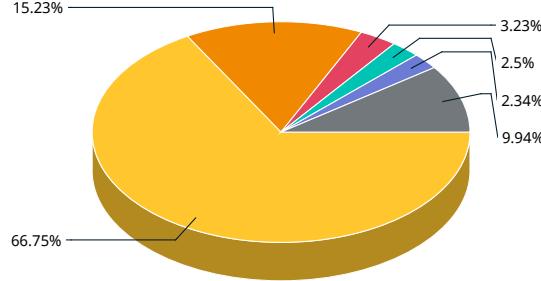
