

MSCI EMU ESG Screened Choice Index (GBP)

The MSCI MSCI EMU ESG Screened Choice Index is a free float-adjusted market capitalization-weighted index based on MSCI EMU, its parent index, which captures large and mid-cap representation across 10 Developed Markets (DM) countries* in EMU. The index excludes companies that are associated with controversial, civilian, and nuclear weapons as well as tobacco or companies that derive revenues from thermal coal power and extraction of select fossil fuels or companies that are not in compliance with the United Nations Global Compact principles or companies that are involved in Red Flag ESG controversies.

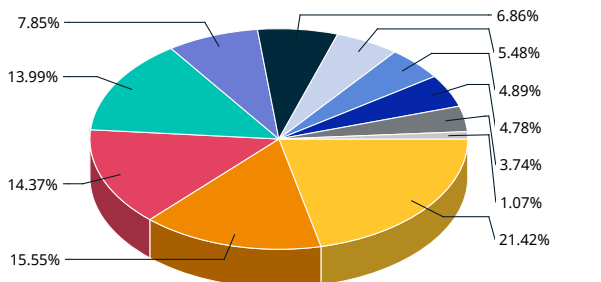

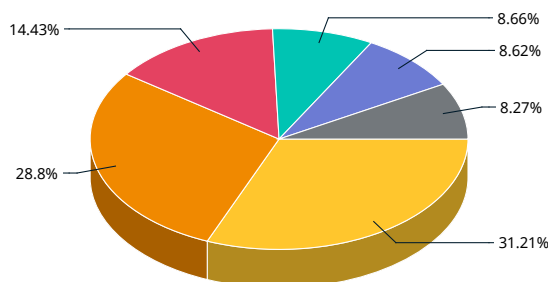
