The Indexes are derived from the MSCI Australia IMI Index and aim to achieve sector weights that reflect the sector weights of the corresponding Parent Index. the MSCI Australia IMI Custom ESG Leaders Index consists of Large, Mid and Small cap companies in Australian markets. The Index construction targets 50% free float-adjusted market capitalization coverage of each Global Industry Classification Standard (GICS®) sector by selecting constituents primarily based on criteria including the ESG rating, the trend in that rating and the company's industry-adjusted ESG score. The Index is a member of the MSCI ESG Leaders Index series.


