# MSCI ACWI EU Paris Aligned Requirements Index (USD)

The MSCI ACWI EU Paris Aligned Requirements Index is based on the MSCI ACWI Index, its parent index, and includes large and mid-cap securities across 23 Developed Markets (DM) and 24 Emerging Markets (EM) countries\*. The index is designed to meet the minimum standards of the EU Paris-Aligned Benchmark (PAB). The index aims to: reduce the weighted average greenhouse gas intensity by 50% compared to the underlying investment universe, reduce the weighted average greenhouse gas (GHG) intensity by 7% on an annualized basis, achieve a modest tracking error compared to the Parent Index and low turnover, exclude companies involved in Controversial Weapons businesses, Very Severe ESG Controversies, Severe Environmental Controversies, Tobacco Manufacturing, Thermal Coal, Oil & Gas and Fossil Fuel-based power generation.




