These criteria exclude constituents based on involvement in specific business activities, as well as ESG ratings and exposure to ESG controversies. The Indexes are derived from the MSCI World ex USA Index and aim to achieve sector weights that reflect the sector weights of the corresponding Parent Index. the MSCI World ex USA Selection Index consists of Large and Mid cap companies in in 22 Developed Markets Countries* excluding USA. The Index construction targets 50% free float-adjusted market capitalization coverage of each Global Industry Classification Standard (GICS®) sector by selecting constituents primarily based on criteria including the ESG rating, and the company's industry-adjusted ESG score. The Index is a member of the MSCI Selection Index series.






