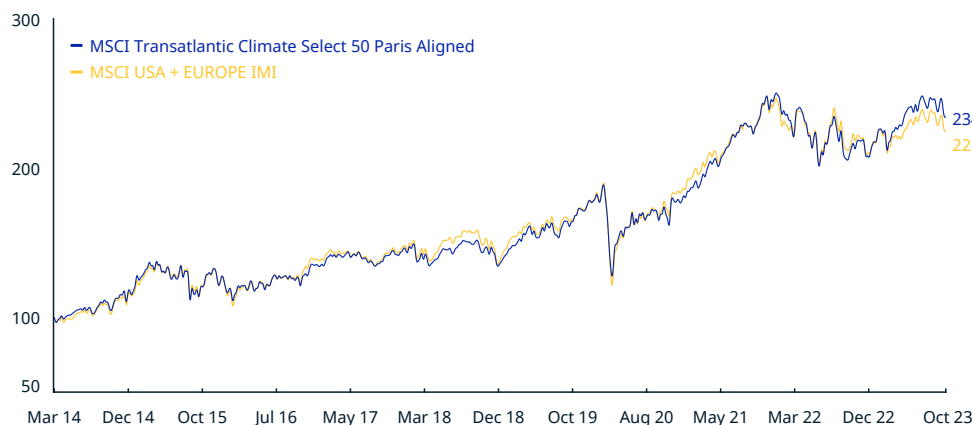


MSCI Transatlantic Climate Select 50 Paris Aligned Index (EUR)

The MSCI Transatlantic Climate Select 50 Paris Aligned Index (“the Index”) is designed to support investors seeking to reduce their exposure to transition and physical climate risks and who wish to pursue opportunities arising from the transition to a lower-carbon economy, while satisfying both the minimum requirements of EU Paris Aligned Benchmarks as per the EU Benchmark Regulation. The Index is constructed from the constituents of an underlying Parent Index, which is the result of first aggregating the constituents of MSCI Europe IMI and MSCI USA IMI, and then renormalizing their weights to 100%.

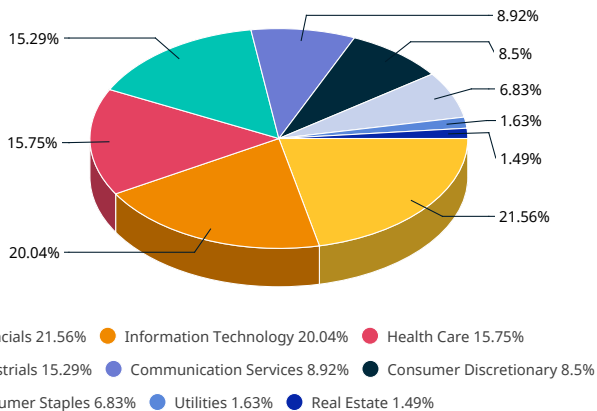

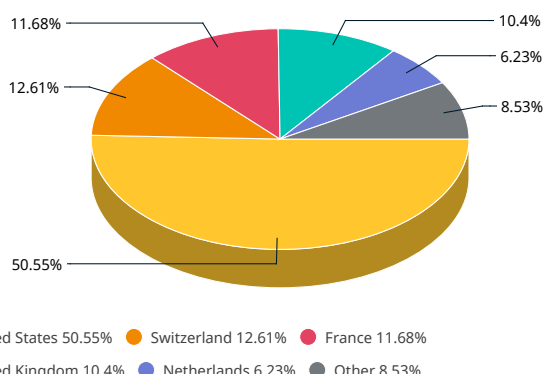
