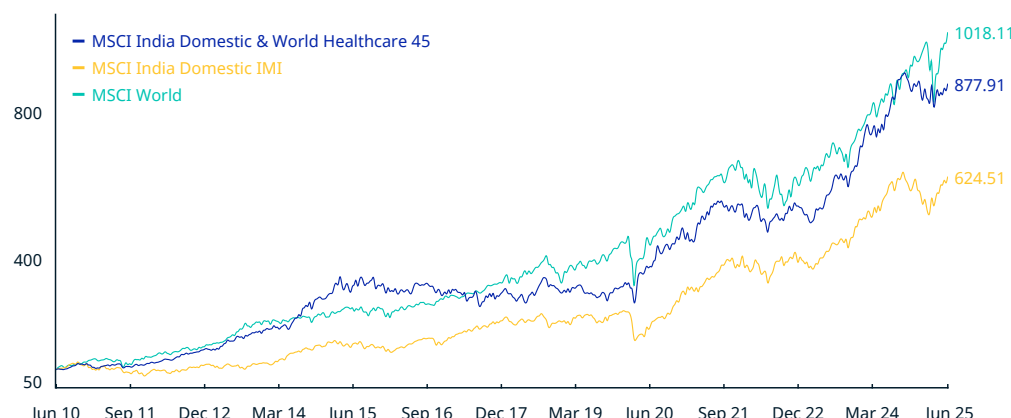


MSCI India Domestic & World Healthcare 45 Index (INR)

The MSCI India Domestic & World Healthcare 45 Index is based on the MSCI India Domestic IMI and the MSCI World Index. The index aims to represent the performance of the 25 largest securities belonging to the select sub-industries in the Healthcare sector of the MSCI India Domestic IMI and the 20 largest belonging to the select sub-industries in the Healthcare sector of the MSCI World Index. All securities in the index are classified in the Health Care sector as per the Global Industry Classification Standard (GICS®).

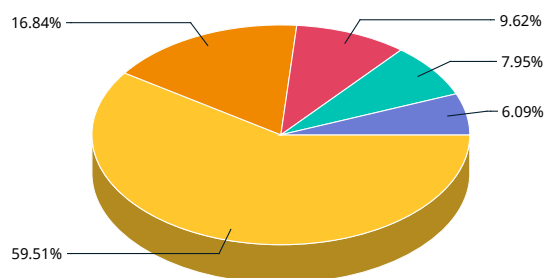
