

MSCI EM Asia with partial A Shares Index (USD)

The **MSCI EM Asia with partial A Shares Index** captures large and mid cap representation across 8 Emerging Markets countries*. With 976 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country. The index reflects the effect of a potential 5% partial inclusion of China A-shares into the MSCI Emerging Markets Index as outlined in the "Index Inclusion Roadmap for China A-Shares in the MSCI Emerging Markets Index" consultation proposal as part of MSCI's Annual Market Classification Review.

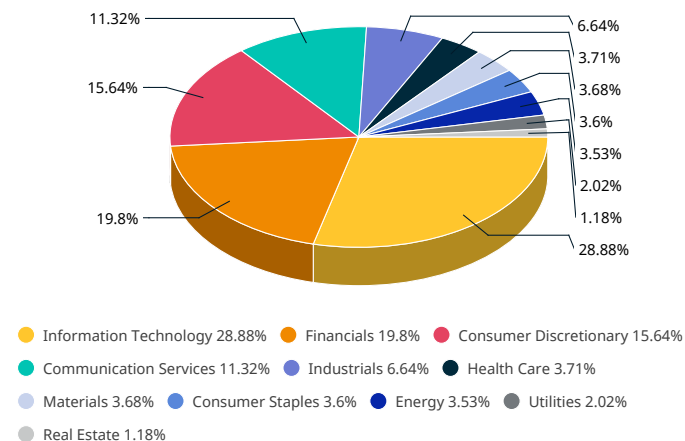

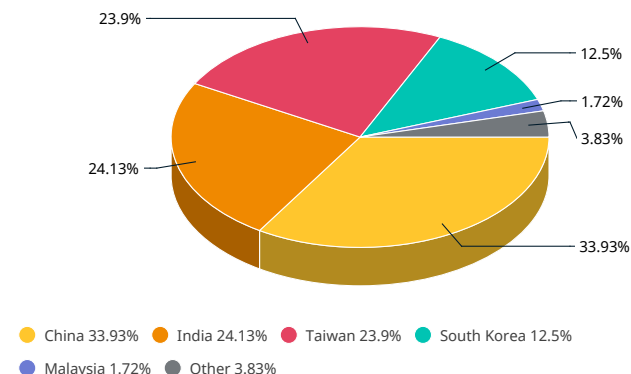
