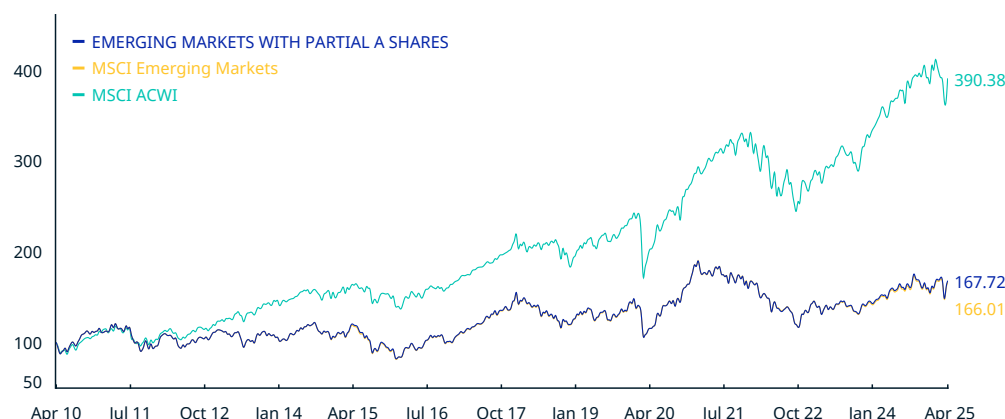


MSCI Emerging Markets with partial A Shares Index (USD)

The MSCI Emerging Markets with partial A Shares Index captures large and mid cap representation across 24 Emerging Markets (EM) countries*. With 1,206 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country. The index reflects the effect of a potential 5% partial inclusion of China A-shares into the MSCI Emerging Markets Index as outlined in the "Index Inclusion Roadmap for China A-Shares in the MSCI Emerging Markets Index" consultation proposal as part of MSCI's Annual Market Classification Review.

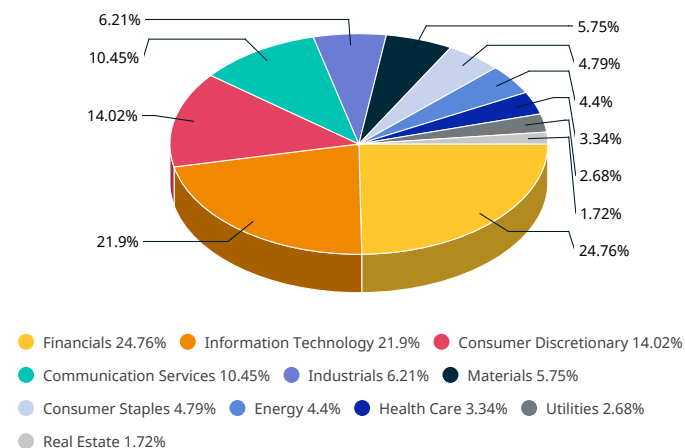

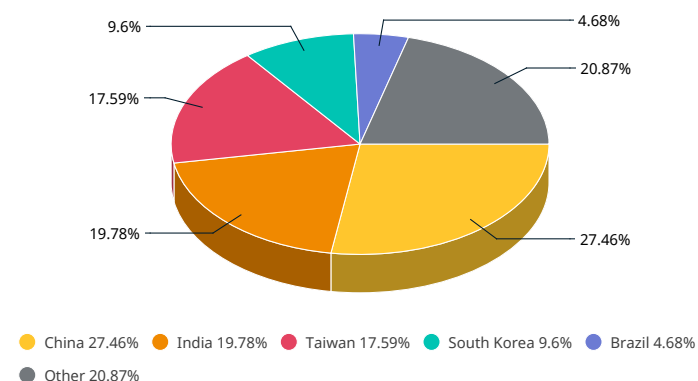
