

MSCI Emerging Markets Asia Custom Capped Index (USD)

The MSCI Emerging Markets Asia Custom Capped Index captures the performance of the large and mid-cap segments across 8 Emerging Markets (EM) countries* in Asia. The MSCI Emerging Markets Asia Custom Capped Index uses a variation of MSCI 25/50 Indexes methodology, where the weight of any single group entity will be constrained at 22.5% of the Index weight, and the sum of the weights of all group entities representing more than 4.50% weight will be constrained at 22.5% of the Index weight.

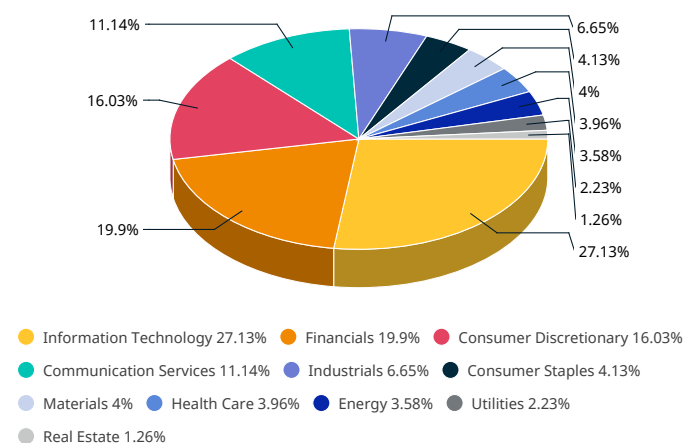

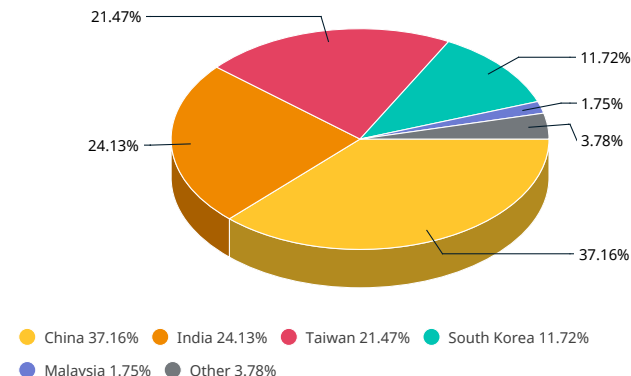
