

# MSCI Emerging Markets Asia ex China 10/40 Index (USD)

The MSCI Emerging Markets (EM) Asia ex China 10/40 Index captures large and mid cap representation across 7 of the 8 Emerging Markets countries\* excluding China. The MSCI 10/40 equity indexes are designed and maintained on a daily basis to take into consideration the 10% and 40% concentration constraints on funds subject to the UCITS III Directive. With 408 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country.

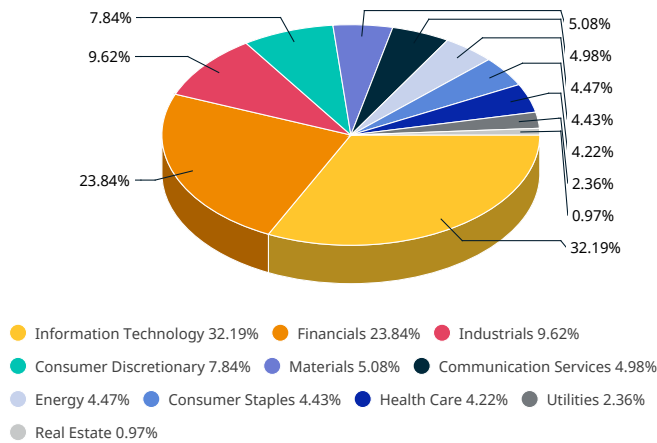
