# **MSCI Europe Islamic ESG Universal Screened Select Index (EUR)**

The MSCI Europe Islamic ESG Universal Screened Select Index is based on the MSCI Europe Islamic Index, its parent index, which reflects Sharia investment principles and includes large and mid-cap securities across 15 Developed Markets (DM)\* countries. The index applies stringent screens to exclude securities based on two types of criteria: business activities and financial ratios derived from total assets. The index is constructed by applying values and climate-based exclusion criteria on the underlying MSCI Islamic Index (the "Parent Index") followed by the application of the MSCI ESG Universal Indexes Methodology.




