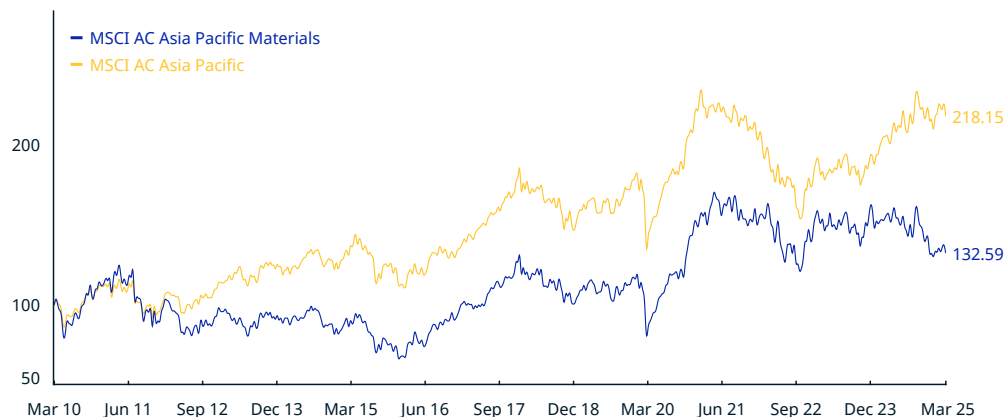


MSCI AC Asia Pacific Materials Index (USD)

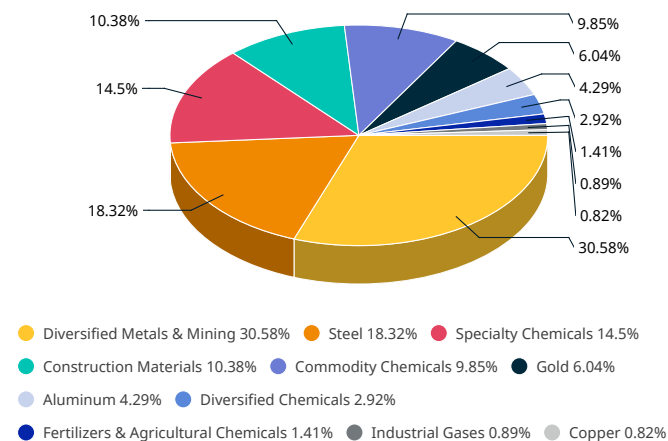

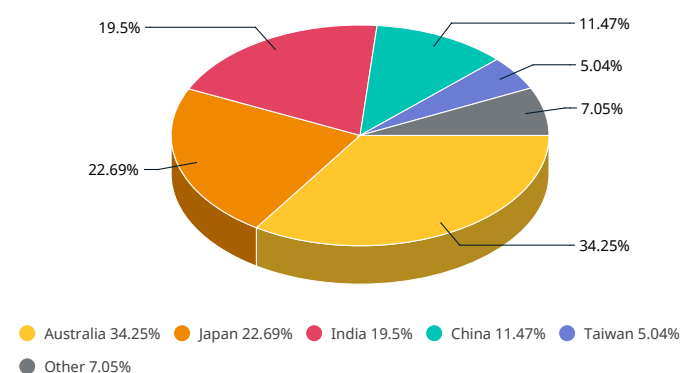
