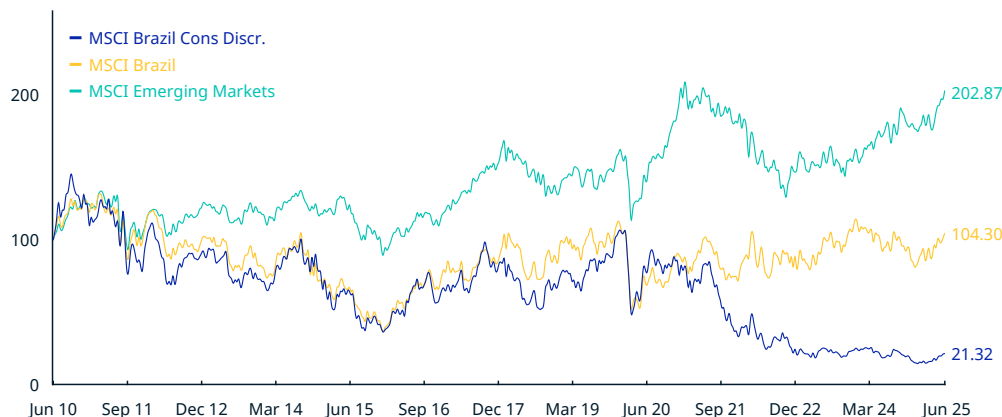


MSCI Brazil Consumer Discretionary Index (USD)

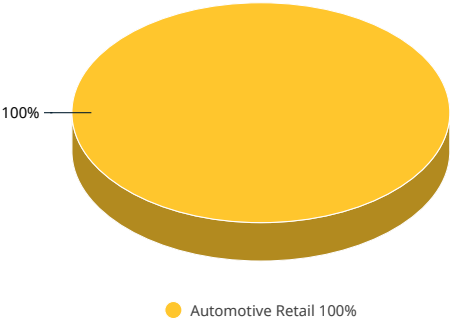
