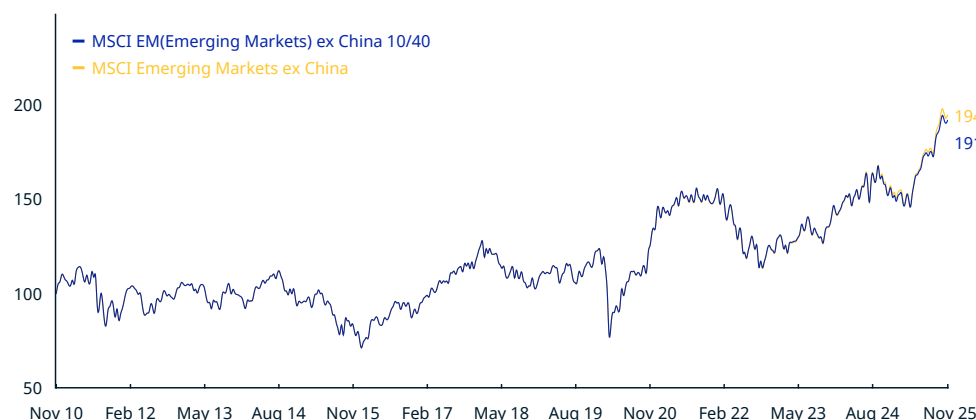


MSCI EM(Emerging Markets) ex China 10/40 Index (USD)

The MSCI EM(Emerging Markets) ex China 10/40 Index captures large and mid cap representation across 23 of the 24 Emerging Markets (EM) countries* excluding China. The MSCI 10/40 equity indexes are designed and maintained on a daily basis to take into consideration the 10% and 40% concentration constraints on funds subject to the UCITS III Directive. With 636 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country.

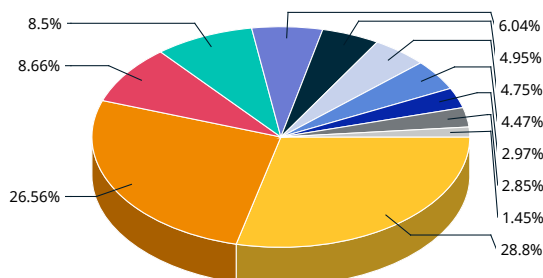
