

MSCI EMU ESG Universal Select Top 50 Index (EUR)

The MSCI EMU ESG Universal Select Top 50 Index is based on the MSCI EMU Index, its parent index, and includes large and mid-cap securities across 10 Developed Markets (DM) countries* in the EMU. The index is designed to represent the performance of 50 stocks from MSCI EMU Index, that are selected based on their 3-month Annualized Traded Value (ATV), and based on the MSCI ESG Screened Indexes and the MSCI ESG Universal Indexes methodologies. Securities are weighted as per the MSCI ESG Universal Indexes methodology, and the top 50 securities based on weight are selected as final constituents of the index.

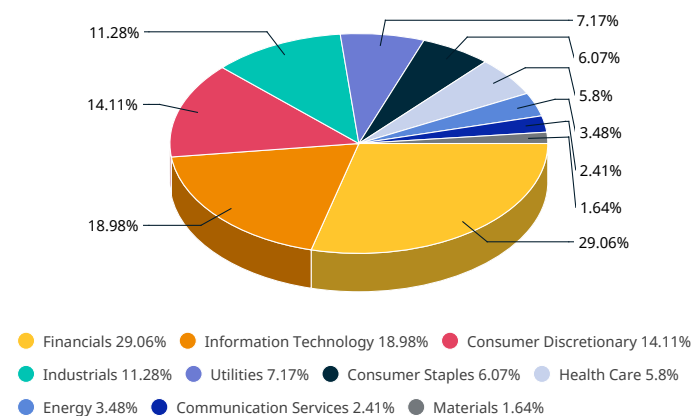

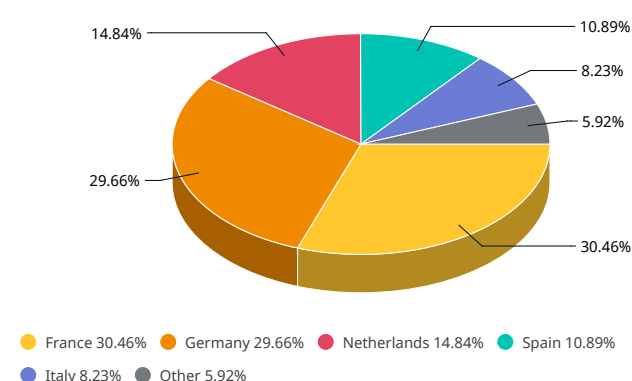
